The Board of Health of the Clermont County General Health District met in regular session on the 12th day of October 2016 with the following members present:

Mr. Crum moved for adoption of the following resolution:

RESOLUTION ESTABLISHING REVISED LICENSE FEES FOR RISK LEVELS I, II, III, IV FOOD SERVICE OPERATIONS AND RETAIL FOOD ESTABLISHMENTS, VENDING FOOD SERVICE LOCATIONS, TEMPORARY FOOD SERVICE OPERATIONS AND RETAIL FOOD ESTABLISHMENTS, MOBILE FOOD SERVICE OPERATIONS AND RETAIL FOOD ESTABLISHMENTS, FOOD SERVICE OPERATION AND RETAIL FOOD ESTABLISHMENT PLAN REVIEWS, FOOD PROGRAM TRAINING FEES, PUBLIC SWIMMING POOLS, PUBLIC SPAS, SPECIAL USE SWIMMING POOLS, PUBLIC SCHOOL SWIMMING POOLS, RECREATIONAL VEHICLE PARKS, RECREATIONAL CAMPS, COMBINED PARK CAMPS, TEMPORARY PARK CAMPS, BODY ART ESTABLISHMENTS, TEMPORARY BODY ART ESTABLISHMENTS, AND RESIDENT CAMPS PURSUANT TO OHIO REVISED CODE SECTION 3709.09 AND 3709.21 .

WHEREAS, the Board of Health of the Clermont County General Health District has the authority pursuant to Ohio Revised Code Sections 3709.09 and 3709.21 to establish a uniform system of fee services; and

WHEREAS, the Board of Health of the Clermont County General Health District is mandated to provide services that protect the public health and prevent or restrict disease, and abate or suppress nuisances; and

WHEREAS, the Board of Health of the Clermont County General Health District has determined that it is necessary to revise the license fees for risk levels I, II, III, iv food service operations and retail food establishments, vending food service locations, temporary food service operations and retail food establishments, mobile food service operations and retail food establishments, food service operation and retail food establishment plan reviews, food program training fees, public swimming pools, public spas, special use swimming pools, public school swimming pools, recreational vehicle parks, recreational camps, combined park camps, temporary park camps, body art establishments, temporary body art establishments, and resident camps; and

WHEREAS, the Board of Health of the Clermont County General Health District did direct the Health Commissioner to notify all entities that would be affected by the proposed fee at least 20 days prior to the September 14, 2016 Board of Health meeting at which time a public hearing on the revised fees was held; and

WHEREAS, the Board of Health of the Clermont County General Health District finds that the Health Commissioner did notify all entities that would be affected by the proposed fees as directed by this Board at least twenty (20) days prior to the September 14, 2016 Board meeting which was prior to passage of this resolution establishing the revised fees.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Health of the Clermont County General Health District, that license fees for the following services be revised as stated:

NOW, THEREFORE, BE IT FURTHER RESOLVED, by this Board of Health of the Clermont County General Health District, that this regulation be published in one newspaper of general circulation that is in the Clermont County General Health District once a week for two consecutive weeks and that the first publication take place no later than 10 days prior to the effective date of the revision adopted herein.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that this Board of Health of the Clermont County General Health District finds and determines that all formal actions relative to the passage of this resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance of the applicable legal requirements, including Section 121.22 of the Ohio Revised Code.
